I acknowledge the contagious nature of communicable diseases, in particular the COVID 19 Coronavirus and that the United States Center for Disease Control (CDC) and many other public health authorities still recommend practicing social distancing.

I further understand that Gaetano Indoor, Inc. has put in place recommended preventative measures that are intended to reduce the spread of communicable diseases including but not limited to COVID 19.

I further understand that Gaetano Indoor, Inc. cannot guarantee my child will not become infected with communicable diseases. I understand that the risk of my child becoming exposed to and/or infected by communicable diseases may result from the actions, inadvertence, omissions, or negligence of myself and others, including, but not limited to, staff, guests and other clients and their families.

I voluntarily seek, for my child, services provided by Gaetano Indoor, Inc. and acknowledge that he/she could be increasing his/her risk to exposure to communicable diseases including but not limited to COVID 19. I understand that my child must comply with all required procedures that are intended to reduce the spread of diseases while he/she is attending Gaetano Indoor, Inc.

I promise, at all times, that when my child is on the Gaetano Indoor, Inc. facility premises, the following will be true:

- * He/she is not experiencing any symptoms of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- * He/she has not traveled internationally within the last 20 days.
- * He/she has not traveled to a highly impacted area within the United States of America in the last 14 days.
- * He/she has not been exposed to someone with a suspected and/or confirmed case of any communicable diseases including but not limited to COVID 19.
- * He/she has not been diagnosed with any communicable diseases, or has been cleared as noncontagious by state or local public health authorities.
- * He/she is following all Center for Disease Control recommended guidelines as much as possible pertaining to Coronavirus and has been limiting his/her exposure to communicable diseases, in particular but not limited to COVID 19.

I hereby release and agree to hold Gaetano Indoor, Inc. harmless from, and waive on behalf of my child, their heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to my child and/or property that may be caused by any act, or failure to act of Gaetano Indoor, Inc. or that may otherwise arise in any way in connection with any services received from Gaetano Indoor, Inc. I understand that this release discharges Gaetano Indoor, Inc. from any liability or claim that I, my heirs, or any personal representatives may have against Gaetano Indoor, Inc. with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received from Gaetano Indoor, Inc. This liability waiver and release extends to the facility together with all owners, partners, and employees.
